### 1. INTRODUCTION

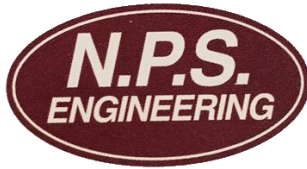

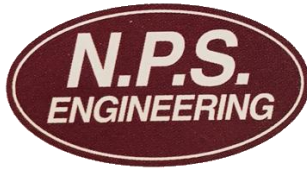
### 5. LINKS TO AND FROM OTHER WEBSITES
